RELEASOR hereby releases, discharges, and covenants not to sue American Obstacle, Inc., its respective shareholders, administrators, directors, agents, officers, volunteers, and employees, other participants, all sponsors, advertisers, and owners and lessors of the premises on which the Activity takes place (each considered one of the RELEASEES herein), from all liability, claims, demands, losses, or damages, on account of injury to the Participant's person or property whether caused by the negligence of any one or more of the RELEASEES or otherwise while Participant is participating in the Activity, including negligent rescue operations; and further agrees that if, despite this release, waiver of liability, and assumption of risk RELEASOR, or anyone on Participant's behalf, makes a claim against any of the RELEASEES, RELEASOR will indemnify, save, and hold harmless each of the RELEASEES from any loss, liability, damage, or cost, which any may incur as the result of such claim.
